REGULATION OF THE PRESIDENT OF THE REPUBLIC OF INDONESIA NUMBER 7 OF 2018 ON AGENCY FOR FOSTERING PANCASILA IDEOLOGY

## ABSTRACT : -

- Pancasila as the basis and ideology of the state, as of the birth on 1 June 1945, as stipulated through Presidential Decree Number 24 of 2016 on the Birth of Pancasila, must be upheld and practiced in various aspects of social, national and state life. In order to uphold and implement Pancasila values, it is necessary to foster Pancasila ideology through a program that is planned, systematic and integrated so that it becomes a guide for all state administrators, national components and Indonesian citizens. The Presidential Work Unit for fostering Pancasila Ideology, which has been fostering Pancasila ideology, needs organization, duties and functions to be perfected and revitalized so that it becomes the Agency for Fostering Pancasila Ideology that can effectively carry out its duties and functions. Presidential Regulation Number 54 of 2017 on the Presidential Working Unit for Pancasila Ideology Development needs to be replaced in the terms of strengthening the fostering of Pancasila ideology in the life of society, nation and state. Based on these considerations, it is necessary to issue a Presidential Regulation on Agency for Fostering Pancasila Ideology.
  - Legal Basis of this Presidential Regulation is Article 4 section (1) of the 1945 Constitution of the Republic of Indonesia.
  - This Presidential Regulation regulates the Agency for Fostering Pancasila Ideology (BPIP) which includes: position; job and function; organization; appointment and dismissal; financial rights and facilities; work procedures; and funding. BPIP is an agency that is under and responsible to the President. BPIP has the duties of assisting the President in formulating the policy direction for fostering Pancasila ideology, carrying out coordination, conducting synchronization, and controlling the fostering of Pancasila ideology in a comprehensive and sustainable manner, and carrying out the preparation of standardization of education and training, organizing education and training, as well as providing recommendations based on the results of studies on policies or regulations that conflict with Pancasila to state high institutions, ministries/institutions, local governments, socio-political organizations, and other components of society.

## NOTES

- This Presidential Regulation comes into force on the date of its promulgation, 28 February 2018 and is issued on 28 February 2018.
  - At the time this Presidential Regulation comes into force, Presidential Regulation Number 54 of 2017 on the Presidential Work Unit for Fostering Pancasila Ideology (State Gazette of the Republic of Indonesia of 2017 Number 101), is repealed and declared ineffective.
