BASIC SUBSTANCES ON FOSTERING PANCASILA IDEOLOGY 2022 BPIP REGULATION NO. 2 OF 2022, BULLETIN GAZETTE 2022/NO. 487, 58 PAGES. REGULATION OF THE AGENCY FOR FOSTERING PANCASILA IDEOLOGY ON BASIC SUBSTANCES ON FOSTERING PANCASILA IDEOLOGY

- ABSTRCT : In order to provide the understanding, elaboration, and basis for implementing the Pancasila ideology fostering program, it is necessary to prepare basic substances on fostering Pancasila ideology that are in accordance with the authentic history of the birth and formulation of Pancasila. It is necessary to improve the material content of Regulation of the Agency for Fostering Pancasila Ideology Number 7 of 2021 on Basic Substances on Fostering Pancasila Ideology by superseding it with a new Agency Regulation. Based on these considerations, it is necessary to issue a Regulation of the Agency for Fostering Pancasila Ideology on Basic Substances on Fostering Pancasila Ideology.
 - Legal Basis of this Regulation of the Agency for Fostering Pancasila Ideology is Presidential Regulation Number 7 of 2018; BPIP Regulation Number 5 of 2021.
 - Regulations of the Agency for Fostering Pancasila Ideology regulates the Basic Substances on Fostering Pancasila Ideology. PIP Basic Substances is material prepared to understand, explain and provide a basis for implementing the development of the Pancasila ideology as the basis of the state, way of life and state ideology for the entire Indonesian people in social, national and state life. The implementation of PIP Basic Substances aims to shape national character which is the basis for the actualization of Pancasila in social, national and state life. This Agency Regulation is the legal basis for the use of PIP Basic Substances in the implementation of PIP carried out by BPIP, high state institutions, ministries/institutions, regional governments, socio-political organizations and other components of society. The Basic Substances for PIP consists of the history of the birth and formulation of Pancasila, the main ideas of Pancasila, the position of Pancasila in social life, the Pancasila democratic nation and state, the Pancasila economic system, and national development based on Pancasila. BPIP disseminates PIP Basic Substances to high state institutions, ministries/institutions, regional governments, socio-political organizations and other components of society. BPIP carries out control and evaluation of the use of PIP Basic Substances at least 1 (one) time in 1 (one) year. The results of control and evaluation are formulated in recommendations for control and evaluation of PIP Basic Substances which are submitted to the Head of the BPIP through the Deputy. The Deputy carries out periodic reviews of the substance of the PIP Basic Substances at least 1 (one) time in 1 (one) year.
- NOTES
- : This Regulation of the Agency for Fostering Pancasila Ideology comes into force on the date of its promulgation, 19 May 2022 and is issued on 17 May 2022;
 - At the time this Agency Regulation comes into force, Regulation of the Agency for Fostering Pancasila Ideology Number 7 of 2021 on Basic Substances on Fostering Pancasila Ideology (State Bulletin of the Republic of Indonesia of 2021 Number 1392), is repealed and declared ineffective.
