

REGULATION OF THE PRESIDENT OF THE REPUBLIC OF INDONESIA
NUMBER 7 OF 2018
ON
AGENCY FOR FOSTERING PANCASILA IDEOLOGY
BY THE BLESSINGS OF ALMIGHTY GOD

THE PRESIDENT OF THE REPUBLIC OF INDONESIA,

- Considering:
- a. that Pancasila as the basis and ideology of the state, since its inception on 1 June 1945, as stipulated by Presidential Decree Number 24 of 2016 on the Birth of Pancasila must be upheld and actualized in all aspects in the life of society, nation, and state;
 - b. that in order to uphold and implement Pancasila values, it is necessary to foster Pancasila ideology through planned, systematic, and integrated programs so that they become a guideline for all state administrators, components of the nation, and Indonesian citizens;
 - c. that the organization, duties and functions of the Presidential Work Unit for Fostering Pancasila Ideology which has so far carried out the fostering of Pancasila ideology need to be perfected and revitalized so that it becomes an Agency for Fostering Pancasila Ideology which can effectively carry out its duties and functions;
 - d. that it is necessary to replace Presidential Regulation Number 54 of 2017 on Presidential Work Unit for Fostering Pancasila Ideology in order to strengthen the fostering of Pancasila ideology in the life of society, nation, and state;

- e. that based on the considerations as referred to in point a, point b, point c, and point d, it is necessary to issue a Presidential Regulation on the Agency for Fostering Pancasila Ideology;

Observing : Article 4 section (1) of the 1945 Constitution of the Republic of Indonesia;

HAS DECIDED:

To issue : PRESIDENTIAL REGULATION ON AGENCY FOR FOSTERING PANCASILA IDEOLOGY.

CHAPTER I GENERAL PROVISIONS

Article 1

In this Presidential Regulation:

1. Agency for Fostering Pancasila Ideology (Badan Pembinaan Ideologi Pancasila), hereinafter abbreviated as BPIP, means an institution that is under the authority of and responsible to the President.
2. Leaders mean the Steering Council, Head and Deputy Head of the BPIP.
3. Steering Council means an element of the BPIP leaders which is institutionally led by a Chairperson who has duties of providing direction and guidance to the Executives regarding the policy direction for fostering Pancasila ideology.
4. Head of BPIP, hereinafter referred to as the Head, means an element of the BPIP leaders who is responsible for carrying out the duties and functions of the BPIP.
5. Deputy Head of BPIP, hereinafter referred to as the Deputy Head, means an element of the BPIP leaders who has duties of assisting the Head and is responsible for carrying out the duties and functions of the BPIP.

CHAPTER II
POSITION

Article 2

- (1) This Presidential Regulation establishes the BPIP that constitutes a revitalization of the Presidential Work Unit for Fostering Pancasila Ideology.
- (2) The BPIP as referred to in section (1) is under the authority of and responsible to the President.
- (3) The BPIP is led by the Head and assisted by the Deputy Head.

CHAPTER III
DUTIES AND FUNCTIONS

Part One
Duties

Article 3

The BPIP has the duties of assisting the President in formulating the policy direction for fostering Pancasila ideology; carrying out coordination, synchronization, and control of fostering Pancasila ideology in a comprehensive and sustainable manner; carrying out the preparation of standardization of education and training; organizing education and training; and providing recommendations based on the results of studies on policies or regulations that are contrary to Pancasila to high state institutions, ministries/institutions, local governments, sociopolitical organizations, and other community components.

Part Two
Functions

Article 4

In carrying out its duties as referred to in Article 3, the BPIP has the following functions of:

- a. formulating the policy direction for fostering Pancasila ideology;
- b. drafting policy guidelines of the Pancasila ideology and a road map on fostering Pancasila ideology;
- c. drafting and implementing work plans and programs on fostering Pancasila ideology;
- d. coordinating, synchronizing, and controlling the implementation of fostering Pancasila ideology;
- e. regulating the fostering of Pancasila ideology;
- f. monitoring and evaluation, and proposing steps and strategies to enhance implementation of fostering Pancasila ideology;
- g. implementing information dissemination and cooperation as well as relations with high state institutions, ministries/institutions, local governments, sociopolitical organizations, and other community components in the implementation of fostering Pancasila ideology;
- h. studying substance and methodology of learning Pancasila;
- i. advocating the implementation of fostering Pancasila ideology in the establishment and implementation of regulations;
- j. drafting standardization of Pancasila education and training as well as organizing education and training; and
- k. formulating and submitting policy recommendations or regulations that are contrary to Pancasila.

CHAPTER IV ORGANIZATION

Part One Organizational Structure

Article 5

The organizational structure of BPIP consists of:

- a. Steering Council, consisting of:
 1. Chairperson; and
 2. Members.

- b. Executives, consisting of:
 1. Head;
 2. Deputy Head;
 3. Principal Secretariat;
 4. Deputy for Interinstitutional Relations, Information Dissemination, Communication, and Networks;
 5. Deputy for Legal, Advocation, and Regulatory Oversight;
 6. Deputy for Studies and Substance;
 7. Deputy for Education and Training; and
 8. Deputy for Control and Evaluation.

Part Two
Steering Council

Article 6

- (1) The Steering Council has the duties of providing direction to the Executives regarding the policy direction for fostering Pancasila ideology.
- (2) The direction as referred to in section (1) is the result of deliberation in the Steering Council meeting.
- (3) The direction as referred to in section (2) is stipulated by the Chairperson of the Steering Council.

Article 7

The Steering Council consists of a maximum of 11 (eleven) persons, comprising elements of:

- a. state figures;
- b. religious and community figures; and
- c. retired figures from the Indonesian National Defense Forces (TNI)/the Indonesian National Police (Polri), retired civil servants and academics.

Article 8

The Chairperson of the Steering Council is elected from and by the members of the Steering Council through the internal mechanism of the Steering Council.

Article 9

- (1) In carrying out its duties, the Steering Council is assisted by a maximum of 3 (three) Special Staff.
- (2) The Special Staff of the Steering Council is under the authority of and responsible to the Chairperson of the Steering Council.
- (3) The provisions regarding the duties of the Special Staff of the Steering Council are stipulated by the Chairperson of the Steering Council.

Article 10

In certain situation, the Chairperson of the Steering Council may establish a special task force to assist in the effective implementation of duties.

Article 11

- (1) To support the implementation of the duties, the Chairperson of the Steering Council may establish an Expert Council.
- (2) The provisions regarding the duties of the Expert Council are stipulated by the Chairperson of the Steering Council.

Article 12

- (1) To provide technical and administrative supports to the Steering Council, a Steering Council Secretariat is established as part of the Principal Secretariat organizational unit.
- (2) The Steering Council Secretariat as referred to in section (1) is led by a Secretary that is functionally responsible to the Chairperson of the Steering Council and administratively responsible to the Principal Secretary.

Part Three

Head

Article 13

The Head has the duties of leading and is responsible for the implementation of duties and functions of the BPIP.

Article 14

- (1) In carrying out its duties, the Head takes into account the direction of the Chairperson of the Steering Council.
- (2) In carrying out the duties as referred to in section (1), the Head assisted by the Deputy Head may establish the BPIP regulations and other regulations upon having consultation with and obtaining approval from the Chairperson of the Steering Council.

Part Four

Deputy Head

Article 15

- (1) The Deputy Head has the duties of assisting the Head in carrying out its duties in leading the BPIP.
- (2) The provisions regarding the duties of the Deputy Head are regulated in the BPIP regulation.

Part Five

Principal Secretariat

Article 16

- (1) The Principal Secretariat is under the authority of and responsible to the Leaders through the Head of the BPIP.
- (2) The Principal Secretariat as referred to in section (1) is led by a Principal Secretary.

Article 17

The Principal Secretariat has the duties of coordinating the implementation of duties, fostering, and provision of administrative and technical supports to organizational units in the BPIP.

Article 18

In carrying out the duties as referred to in Article 17, the Principal Secretariat has the following functions of:

- a. coordinating activities in the BPIP;
- b. coordinating the draft of plans, programs, activities and budgets in the BPIP;
- c. fostering and providing administrative support which includes administration, personnel affairs, finance, household affairs, cooperation, public relations, archives, and documentation;
- d. fostering and structuring the organization and work procedures;
- e. coordinating and drafting legislation as well as the implementation of legal advocacy;
- f. administering the management of state property/assets and service for the procurement of goods/services;
- g. implementing internal supervision in the BPIP; and
- h. performing other functions assigned by the Leaders.

Article 19

- (1) The Principal Secretariat consists of a maximum of 5 (five) Bureaus.
- (2) The Bureau as referred to in section (1) consists of a maximum of 3 (three) Divisions and/or a Group of Functional Positions.
- (3) A Division consists of a maximum of 3 (three) Subdivisions
- (4) Apart from the provision as referred to in section (3), the Division handling the administration of the leaders consists of a number of Subdivisions according to the needs.

Article 20

One of the Bureaus in the Principal Secretariat as referred to in Article 19 section (1) becomes the Steering Council Secretariat that has duties to assist and facilitate the Steering Council in carrying out its duties.

Part Six

Deputy for Interinstitutional Relations, Information
Dissemination, Communication, and Networks

Article 21

- (1) The Deputy for Interinstitutional Relations, Information Dissemination, Communication, and Networks is under the authority of and responsible to the Leaders through the Head of the BPIP.
- (2) The office of the Deputy for Interinstitutional Relations, Information Dissemination, Communication, and Networks is led by a Deputy.

Article 22

The Deputy for Interinstitutional Relations, Information Dissemination, Communication, and Networks has duties of implementing strategic programs of interinstitutional relations, information dissemination, communication, and networks of fostering Pancasila ideology.

Article 23

In carrying out its duties as referred to in Article 22, the Deputy for Interinstitutional Relations, Information Dissemination, Communication, and Networks carries out the functions of:

- a. coordinating and synchronizing the strategic and work programs of fostering the Pancasila ideology with the high state institutions, ministries/institutions, regional governments, sociopolitical organizations, and other community components;
- b. coordinating the volunteers of Pancasila virtue movement;
- c. internalizing the value of *gotong royong* (mutual cooperation) in the society in mainstreaming the values of Pancasila;
- d. disseminating information on Pancasila or the comprehension, internalization, and actualization of Pancasila through the mass media, social media, interpersonal media, advertisement, discussion forum, festival, visitation, and cultural diplomacy;

- e. developing communication with mass media;
- f. improving the quality of cooperation and relations with high state institutions, ministries/institutions, and local governments;
- g. developing relations with sociopolitical organizations and other community components in order to engage the community to participate; and
- h. performing other functions assigned by the Leaders.

Article 24

- (1) The Deputy for Interinstitutional Relations, Information Dissemination, Communication, and Networks consists of a maximum of 3 (three) Directorates.
- (2) Each Directorate as referred to in section (1) consists of a maximum of 3 (three) Subdirectorates and/or a group of functional positions.
- (3) Each Subdirectorate as referred to in section (2) consists of a maximum of 2 (two) Sections and/or a group of functional positions.

Part Seven

Deputy for Legal, Advocacy, and Regulatory Oversight

Article 25

- (1) The Deputy for Legal, Advocacy, and Regulatory Oversight is under the authority of and responsible to the Leaders through the Head of the BPIP.
- (2) The office of Deputy for Legal, Advocacy, and Regulatory Oversight is led by a Deputy.

Article 26

The Deputy for Legal, Advocacy, and Regulatory Oversight has duties of internalizing and institutionalizing Pancasila in the fields of legal, advocacy, and regulatory oversight.

Article 27

In carrying out its duties as referred to in Article 26, the Deputy

for Legal, Advocacy and Regulatory Oversight carries out the functions of:

- a. formulating the policy direction for internalizing and institutionalizing Pancasila in the fields of legal, advocacy, and regulatory oversight;
- b. institutionalizing Pancasila to the national law in order to synchronize it with the state ideology;
- c. giving recommendation based on the result of monitoring and study on high state institutions, ministries/institutions, and local government on the regulations that are contrary to the basic values of Pancasila;
- d. carrying out the advocacy of fostering Pancasila ideology for high state institutions, ministries/institutions, local government, sociopolitical organizations, and other community components;
- e. handling the settlement and solving problems and obstacles in fostering Pancasila ideology; and
- f. performing other functions assigned by the Leaders.

Article 28

- (1) The Deputy for Legal, Advocacy, and Regulatory Oversight consists of a maximum of 3 (three) Directorates.
- (2) Each Directorate as referred to in section (1) consists of a maximum of 3 (three) Subdirectorates and/or a group of functional positions.
- (3) Each Subdirectorate as referred to in section (2) consists of a maximum of 2 (two) Sections and/or a group of functional positions.

Part Eight

Deputy for Studies and Substance

Article 29

- (1) The Deputy for Studies and Substance is under the authority of and responsible to the Leaders through the Head of the BPIP.

- (2) The office of the Deputy for Studies and Substance is led by a Deputy.

Article 30

The Deputy for Studies and Substance has duties of formulating policy direction on fostering Pancasila ideology, studying and formulating the standardization of substance for fostering Pancasila ideology.

Article 31

In carrying out its duties as referred to in Article 30, the Deputy for Studies and Substance carries out the functions of:

- a. formulating policy direction on fostering Pancasila ideology;
- b. formulating the policy guidelines of Pancasila ideology and roadmap of fostering Pancasila ideology;
- c. studying the implementation on fostering Pancasila ideology;
- d. formulating the substance standardization and teaching materials for the method of fostering Pancasila ideology;
- e. identifying the values of Pancasila ideology in policies, programs, and activities of high state institutions, ministries/institutions, local governments, sociopolitical organizations, and other community components;
- f. coordinating and synchronizing the formulation of policy on fostering Pancasila ideology;
- g. garnering public opinion and handling public aspiration to formulate policy on fostering Pancasila ideology; and
- h. performing other functions assigned by the Leaders.

Article 32

- (1) The Deputy for Studies and Substance consists of a maximum of 3 (three) Directorates.
- (2) Each Directorate as referred to in section (1) consists of a maximum of 3 (three) Subdirectorates and/or a group of functional positions.
- (3) Each Subdirectorate as referred to in section (2) consists of

a maximum of 2 (two) Sections and/or a group of functional positions.

Part Nine

Deputy for Education and Training

Article 33

- (1) The Deputy for Education and Training is under the authority of and responsible to the Leaders through the Head of the BPIP.
- (2) The office of Deputy for Education and Training is led by a Deputy.

Article 34

The Deputy for Education and Training has duties of organizing education and training on fostering Pancasila ideology.

Article 35

In carrying out its duties as referred to in Article 34, the Deputy for Education and Training has the functions of:

- a. drafting plans and programs for education and training on fostering Pancasila ideology;
- b. drafting standardization for education and training on fostering Pancasila ideology;
- c. drafting curriculum of education and training on fostering Pancasila ideology;
- d. organizing education and training on fostering Pancasila ideology for state apparatus, members of sociopolitical organizations, and other community components; and
- e. performing other functions assigned by the Leaders.

Article 36

- (1) The Deputy for Education and Training consists of a maximum of 3 (three) Directorates.
- (2) Each Directorate as referred to in section (1) consists of a maximum of 3 (three) Subdirectorates and/or a group of functional positions.

- (3) Each Subdirectorate as referred to in section (2) consists of a maximum of 2 (two) Sections and/or a group of functional positions.

Part Ten

Deputy for Control and Evaluation

Article 37

- (1) Deputy for Control and Evaluation is under the authority and responsible to the Leaders through the Chairperson of BPIP.
- (2) The office of Deputy for Control and Evaluation is led by a Deputy.

Article 38

The Deputy for Control and Evaluation has the duties of carrying out control, monitoring, and evaluation in the implementation of policies on fostering Pancasila ideology.

Article 39

In carrying out its duties as referred to in Article 38, the Deputy for Control and Evaluation has the functions of:

- a. controlling the implementation on fostering Pancasila ideology;
- b. monitoring and evaluating the implementation of policies on fostering Pancasila ideology;
- c. carrying out the assessment of Pancasila institutionalization in policies, regulations, and state administration practices;
- d. proposing steps and strategies to enhance implementation on fostering Pancasila ideology; and
- e. performing other functions assigned by the Leaders.

Article 40

- (1) The Deputy for Control and Evaluation consists of a maximum of 3 (three) Directorates.
- (2) Each Directorate as referred to in section (1) consists of a maximum of 3 (three) Subdirectorates and/or a group of functional positions.

- (3) Each Subdirectorate as referred to in section (2) consists of a maximum of 2 (two) Sections and/or a group of functional positions.

Part Eleven

Center

Article 41

- (1) The Center may be established as a supporting organization for carrying out the duties and functions of the BPIP.
- (2) The Center as referred to in section (1) is under the authority of and responsible to the Head through the Principal Secretary.
- (3) The Center as referred to in section (1) consists of a maximum of 2 (two) Sectors, 1 (one) Subdivision for Administrative Affairs, and a group of functional positions.
- (4) The Center is led by the Head of the Center.

Part Twelve

Functional Positions

Article 42

Functional positions may be established in the BPIP according to the needs whose implementation is carried out in accordance with the provisions of legislation.

Part Thirteen

Expert Group

Article 43

- (1) An Expert group may be appointed in accordance with the provisions of legislation.
- (2) The provisions regarding the duties and appointment of the expert group are regulated by the BPIP Regulation.

Article 44

Further provisions regarding the duties, functions, organizational structure, and work procedures of the BPIP are

regulated by the BPIP Regulation upon obtaining approval from the minister that administers Government affairs in the field of the state apparatus.

CHAPTER V APPOINTMENT AND DISMISSAL

Article 45

- (1) The Steering Council, Head, and Deputy Head are appointed and dismissed by the President.
- (2) The Principal Secretary and the Deputies are appointed and dismissed by the President on the recommendation of the Head and/or the Deputy Head after obtaining approval from the Chairperson of the Steering Council.
- (3) The Appointment of the Principal Secretary and Deputies as referred to in section (2) is carried out after a selection process in accordance with the provisions of legislation.
- (4) The Special Staff of the Steering Council is appointed and dismissed by the Chairperson of the Steering Council.

Article 46

- (1) The term of office of the Steering Council, Head, and Deputy Head is valid for 1 (one) period of 5 (five) years and may be reappointed for the next 1 (one) period.
- (2) For the first time, the Steering Council and the Head who have been appointed based on Presidential Regulation Number 54 of 2017 on Presidential Work Unit for Fostering Pancasila Ideology will continue to carry out their duties for 5 (five) years from the date of appointment.

Article 47

The Steering Council, Head, Deputy Head, Deputies, and Special Staff of the Steering Council may be appointed from civil servants or non-civil servants.

Article 48

Civil servants appointed as the employees of the BPIP are

dismissed from their organic positions without losing their status as civil servants.

Article 49

- (1) Civil servants who have resigned or have finished their term of service as employees of the BPIP are reactivated in organic positions according to the formation available in accordance with the provisions of legislation.
- (2) Civil servants who are appointed as employees of the BPIP are honorably discharged as civil servants when they have reached the retirement age limit and are granted their rights in accordance with the provisions of legislation.

Article 50

Heads of Bureaus, Directors, Heads of Centers, Heads of Divisions, Heads of Subdirectorates, Heads of Sectors, Heads of Subdivisions, and Heads of Sections at the BPIP are appointed and dismissed by the Principal Secretary after obtaining approval from the Chairperson of the Steering Council in accordance with the provisions of legislation.

Article 51

- (1) The Principal Secretary is *madya* middle-level senior leadership position or structural position of echelon I.a.
- (2) Heads of Bureaus, Directors, and Heads of Centers are *pratama* first-level senior leadership positions or structural positions of echelon II.a.
- (3) Heads of Divisions, Heads of Subdirectorates, and Heads of Sectors are an administrator positions or structural position of echelon III.a.
- (4) Heads of Subdivision and Heads of Sections are supervisor positions or structural positions of echelon IV.a.

CHAPTER VI
FINANCIAL ENTITLEMENTS AND FACILITIES

Article 52

- (1) The Steering Council is eligible for financial entitlements and other facilities in accordance with the provisions of legislation.
- (2) The Head is eligible for financial entitlements and other facilities at the same level as those of ministerial positions.
- (3) Deputy Head is eligible for financial entitlements and other facilities at the same level as those of vice-ministerial positions.
- (4) Deputies are eligible for financial entitlements and other facilities at the same level as those of *madya* middle-level senior leadership positions or echelon I.a positions.
- (5) Special Staff of the Steering Council are eligible for financial entitlements and other facilities at the same level as those of *madya* middle-level senior leadership positions or echelon I.b positions.

Article 53

The Expert Council and expert group are eligible for financial entitlements and other facilities in accordance with the provisions of legislation.

Article 54

Further provisions regarding financial entitlements and other facilities for BPIP leaders, high-ranking officials and employees are regulated in a Presidential Regulation.

CHAPTER VII
WORK PROCEDURES

Article 55

- (1) Every proposed policy recommendation must be discussed in advance with the Steering Council.
- (2) Every policy recommendation as referred to in section (1)

that is submitted to the President must obtain approval from the Chairperson of the Steering Council.

Article 56

The Head and/or Deputy Head reports on the implementation of their duties to the President through the Chairperson of the Steering Council not less than 1 (one) time every 3 (three) months or at any time if necessary.

Article 57

- (1) In carrying out the duties, the Deputy Head takes into account the direction of the Chairperson of the Steering Council.
- (2) The results of the implementation of the duties as referred to in section (1) are reported to the Head.
- (3) The report as referred to in section (2) is submitted to the Chairperson of the Steering Council.

Article 58

- (1) The Principal Secretary and Deputies may be assigned with other duties in accordance with the direction of Chairperson of the Steering Council through the Head.
- (2) The results of the implementation of the duties as referred to in section (1) are reported to the Head.
- (3) The report as referred to in section (2) is submitted to the Chairperson of the Steering Council.

Article 59

- (1) The Executives may involve ministries/institutions, local governments, sociopolitical organizations, and other community components in meetings to discuss policies on fostering Pancasila ideology.
- (2) In addition to involving ministries/institutions, local governments, sociopolitical organizations, and other community components as referred to in section (1), the Executives carry out coordination steps with high state institutions for the activities on fostering Pancasila ideology.

Article 60

The Head and/or Deputy Head represent the BPIP to attend meetings organized by high state institutions.

CHAPTER VIII
FUNDING

Article 61

The funding for the implementation of the duties and functions of the BPIP is borne by the State Budget in the BPIP Budget Section.

CHAPTER IX
TRANSITIONAL PROVISIONS

Article 62

- (1) The Steering Council and the Head who are currently in office continue to carry out their duties until the end of their term of office as referred to in Article 46.
- (2) The Deputy for the Presidential Work Unit for Fostering Pancasila Ideology appointed based on Presidential Regulation Number 54 of 2017 on Presidential Work Unit for Fostering Pancasila Ideology will continue to carry out the duties until a new Deputy is appointed under this Presidential Regulation.
- (3) The Secretariat of the Presidential Work Unit for Fostering Pancasila Ideology established under Presidential Regulation Number 54 of 2017 on Presidential Work Unit for Fostering Pancasila Ideology will continue to carry out the duties until the Principal Secretariat is established under this Presidential Regulation.

Article 63

- (1) At the time this Presidential Regulation comes into force, funding, personnel, equipment, assets and documents of the Presidential Work Unit the Fostering Pancasila

Ideology are transferred to the BPIP in accordance with the provisions of legislation.(2) The transfer as referred to in section (1) is coordinated by the minister administering the Government affairs in the field of state apparatus and involves stakeholders from the Ministry of Finance, the Ministry of State Secretariat, and Cabinet Secretariat.

- (2) The transfer as referred to in section (1) is carried out within a maximum period of 1 (one) year from the issuance of this Presidential Regulation.

CHAPTER X CLOSING PROVISIONS

Article 64

At the time this Presidential Regulation comes into force, Presidential Regulation Number 54 of 2017 on Presidential Work Unit for Fostering Pancasila Ideology (State Gazette of the Republic of Indonesia of 2017 Number 101), is repealed and declared ineffective.

Article 65

This Presidential Regulation comes into force on the date of its promulgation.

In order that every person may know hereof, it is ordered to promulgate this Presidential Regulation by its placement in the State Gazette of the Republic of Indonesia.
